### Agency Achievements

The Douglas County Sheriff's Office took the following actions in order to continue best practices for compliance with the PREA Standards:

- All PREA investigations are electronically stored on Douglas County Servers. Only designated staff have access to these files. Hard copies will be destroyed following Office policy on records retention and the retention schedule approved by the Colorado State Archivist and the Colorado Attorney General.
- PREA Standard Operating Procedures are reviewed and updated annually to maintain compliance with PREA standards and best practices.
- Douglas County Sheriff's Office website provides information on how to report a suspected incident of sexual abuse or harassment of a person while in custody. An email link along with contact information for the Sheriff's Office is located in the Health, Welfare and Safety of Inmates section.
- Information on PREA is published in the Inmate Handbook and available on inmate tablets.
- All Detentions' staff and volunteers are required to complete recurrent training on PREA standards and expectations.
- The Office has a Memo of Understanding (MOU) with Blue Bench to provide confidential victim advocacy for inmates reporting sexual abuse or harassment.
